- Extracts of the selected film may be broadcast on television and/or radio for promotional purposes only.
- All preview format in the possession of the Festival may be available during the Festival only at an exclusive viewing stand for participants. All exhibition prints and digital files must be received by April 1, 2027 for selected films, The entry of a film to the Boston International Film Festival signifies an acceptance of the regulations and statements provided with and in this form. Those selected will be notified via email or regular mail. On or about March 1, 2027.
